

PART III – Manual of Instructions

Manual of Instruction on Census enumeration was published in Enumerator's Manual & Field Booklet and consisted on 26 pages. This booklet was provided to each of the enumerators and was written in English language. With the aid of this Manual of Instructions the Census Officer gave training to the Enumerators.

In manual of Instruction, it was mentioned that an unoccupied house were to be marked on the map with the letter E (for Empty) and a new house in the area also need to mark in the map. Unfortunately most of the enumerators are not marking unoccupied houses, only few of them followed this instruction. The information on unoccupied houses cannot be available in this census.

Census Schedules

There are 2 types of census schedules:

Household/Dwelling Schedule: this schedule is to be completed for each household by the head of the household. **One schedule per household.**

Population Schedule: this schedule is to be completed by each person in the household. **One population schedule per person.**

Some Definitions

Household/Dwelling

A single person living alone

A group voluntarily living together under one roof, having common housekeeping arrangements for supplying basic living needs, such as principal meals.

The group may consist of related or unrelated persons.

The Instructions says that:

1. Old people who sleep in the house or in a assembly unit or any type of building separate from the main house, but share the cooking facilities and eat together; belong to the same household.
2. A visitor, border or lodger who sleeps in the house or in any type of building separate from the house belongs to the household.
3. If a house or flat is shared by two or more family groups, each of which makes their own arrangements for cooking and eating, such groups should be regarded as constituting separate households. On the other hand if “everyone” in two or more family groups share the kitchen and house and eat together, they are to be regarded as members of one family.

Questions 1 to 8, 29 and 30 were asked to all persons. Question 9 and 10 were asked only to persons aged 5 years and above. Questions 11 to 28 were asked to persons aged 15 years and above.

Household members were asked how they were related to head of household.

Question 2: Gender

Tick ☒ in male or female box.

Question 3: Date of Birth

If respondents forget the date of birth, Enumerator need to assists them in order to have accurate answer as possible.

Question 4: Place of Birth

If the person is Niuean, give mother's home village at time of birth, if overseas give country name at birth.

Question 5: Citizenship

Citizenship of a person was asked and filled as respondent said, but for analysis the following categories were summarized:

Question 6: Decent/Ethnicity

This question refers to persons racial origin or decent. The information on decent/ethnicity can provide how many full blooded Niuean, how many half Niuean, how many European, how many Tongans, how many Samoans, etc. are there.

Question 7: Home Village

This Question refers only to persons who are Niuean decent. The movement of Niueans from village to village (ie. Internal movement) can be obtained from this question.

Question 8: Religion

This question is asked to obtain the distribution of population by religion. The following listed religion are used to analyse:

- Ekalesia Niue
- Latter Day Saints
- Roman Catholic
- Jehovah's Witness
- Seventh Day Adventist
- Others
- None
- Not Stated

Question 9: Highest Level of Education Attained

This question applies to persons 5 years and above. It is asked to find out the highest level of education attained by Niueans. The education level is categorized as follows:

- No Education
- Primary
- Secondary
- Tertiary
- Still at School
- Not Stated

Question 10: Highest Qualification Formally Attained

This question applies to persons 5 years and above. It provides a person's highest qualification acquired in the formal school system during his entire lifespan. Education qualification is categorized as follows:

- No Qualification
- Form 5
- Form 6
- UE
- Trade Certificate
- Diploma
- Degree
- Masters
- Doctorate
- Others
- Not stated

Question 11: Marital Status

This question applies to persons 15 years and above. It is asked to obtain a person's marital Status. Marital Status is categorized as follows:

- Never Married
- Married
- Widow
- Divorced
- Separated
- De Facto

Question 12: Where were you in August 1997?

This question applies to persons 15 years and above. It is asked for migration. The respondent's answer is categorized in three categories as follows:

- This village
- Other village, specify village
- Overseas, specify country

Question 13: Where do you think you will be living in the year 2006?

This question applies to persons 15 years and above. It is asked to obtain people's desire of living in the year 2006. If the answer is other than Niue, respondent must also give the reason of leaving Niue. The respondents' answers are categorized in four categories as follows:

- Niue
- New Zealand
- In both Niue and New Zealand
- Other (specify)

Question 14: Where do you prefer to live?

This question applies to persons 15 years and above. It gives the preference of living place for respondent.

Question 15: The reason of choosing the country in question 14

This question applies to persons 15 years and above. It provides the information why the respondent prefer to live in the country mentioned in question 14.

Question 16: Main Activity during a week prior to census

This question applies to persons 15 years and above. It is asked to obtain employed and unemployed persons, economically active and economically not active persons. The categories of main activities were as follows:

- Working full time for wage or salary
- Working for wages part time (include casual)
- Working mainly to produce own use/household consumption
- Working mainly to produce for sale
- Unemployed
- Domestic duties and not working for wages
- Attending full time education
- Other (pensioner, disabled etc.)

Question 17: Work for profit (a week prior to census)

This question applies to persons 15 years and above. It also asked whether the person is worked for profit. If he does so total working hour is also available.

Question 18: Any work on fishing or Plantation a week prior to census

This question applies to persons 15 years and above. It finds out whether a person worked on Fishing or/and Plantation last week.

Question 19: Work for own family use, occasionally sell or Regularly sell

This question applies to persons 15 years and above. It finds out that a person worked for his own family use or occasionally sell or regularly sell.

Question 20: Looked for any(other) work

This question applies to persons 15 years and above. It finds out that whether a person look for any job or any other job.

Question 21: Availability for paid (other) work a week prior to census

This question applies to persons 15 years and above. It finds out whether a person is whether available for paid work or other work last week.

Question 22 Hours worked last week

This question applies to persons 15 years and above. It gives information on number of hours worked during a week prior to census

Question 23 Employment Status

This question applies to persons 15 years and above. It provides an employment Status of a person. It is categorized as follows:

- Government
- Private Sector
- Self Employed/Family
- Business
- Other (specfy)

Question 24 Occupation

This question applies to persons 15 years and above. It records all occupation said by the respondent.

Occupation is the work done by a person as a means of livelihood to earn income either in cash or in kind. It refers only to those who were employed during the specified 7 days, that is the period from 1 September 2001 to 7 September 2001, including unpaid family workers. Only the occupation in which the respondent worked most of the time was recorded for persons with dual occupation.

Question 25: Annual Gross Income

This question applies to persons 15 years and above. Annual gross income is an income before giving tax in terms of New Zealand dollars. It was categorized as follows:

Question 26: Industry

This question applies to persons 15 years and above. It describes the kind of industry, business or service in which a person is engaged in. This does not mean a person's actual job, or the job it does. This question refers to their place of work. For example: Samuel Quartz is a Nurse, then write Health, Cutie Casio's employed as Waitress, then state down Matavai Resort.

Question 27: Smoker or Non-Smoker

This question applies to persons 15 years and above. It was categorized as follows:

- Non-Smoker
- Casual Smoker and
- Heavy Smoker

Question 28 Alcoholic Drinker or Non-Drinker

This question applies to persons 15 years and above. It was categorized as follows:

- Non Alcoholic Drinker
- Social Drinker
- Heavy Drinker

Question 29 Visit Hospital and seen doctor, or public health nurse, or pharmacy for medication only, or traditional healer or an other therapist, healer

This question applies to everyone.

Question 30 This question relate with question 29. If you tick yes to doctor, you need to ask how many consultations have had in the last 12 months. The answer to this question is categorized as follows:

- 1
- 2
- 3-5
- 6-11
- 12+ and Don't know

This question applies to everyone.

Question 31 Number of children still living.

This question applies to all female age 15 years and above. It provides one variable to estimate fertility.

Question 32 Number of children alive at birth now deceased

This question applies to all female age 15 years and above. It provides one variable to estimate mortality.

Question 33 Date of birth of last child born alive

This question applies to all female age 15 years and above. It provides one variable to estimate Infant Mortality Rate (IMR).

Glossary

Terms

Definitions/Descriptions

Age Dependency Ratio	The ratio of the population in the ages defined as dependent (under 15 and over 65 years) to the population in the aged defined as economically productive (15-59 years)
Age-specific fertility rate	Number of births occurring during a specified period to women of a specified age or age group, divided by the number of person-years lived during that period by women of that age or age group.
Balancing equation	Population growth = birth – death + net migration
Childbearing age	The span which women are capable of bearing children, generally taken to be from age 15 to 49.
Children ever borne	Number of children ever borne alive by a particular woman: synonymous with “Parity”. In demographic usage, still birth are specifically excluded.
Crude birth rate	The total number of live births per 1000 population in a given year
Crude death rate	The total number of deaths per 1000 population in a given year
De facto population	Population enumerated on the basis of those present at a particular time, including temporary visitors and excluding residents temporarily absent.
Growth rate	The increase or decrease of a population in a period divided by the number of person-years lived by the population during the same period
Infant mortality rate	Number of deaths of children under one year of age
Life table	Listing of the number of survivors at different ages (up to the highest age attained) in a hypothetical “cohort” subject from birth to a particular set of “age-specific mortality rates”. The survivors of the “radix” to age x are generally denoted by l(x). The

tabulations commonly accompanying a life table include other features of the cohort's experience: its expectation of life at each age x , denoted by e_x , the probability of dying from each age x to age $x+n$, denoted by ${}_nq_x$; the person-years lived by the hypothetical cohort as it ages from age x to age $x+n$ denoted by ${}_nL_x$ (also equivalent to the population age $x, x+n$ in a "stationary population" experiencing a number of births each year equal to the radix of the life table); and the person-years lived by the hypothetical cohort from age x onward, denoted by T_x .

Mean age at childbearing in the population

average age of the mothers of the children born in a population during a year. This measures incorporate the effects of both mortality and age distribution.

Median

The value associated with the central member of a set that is ordered by size or some other characteristics expressed in numbers

Myers Index

An index of digit preference that essentially sums in turn the population ending in each digit over some age range 10-79 expressing the total as a percentage of the total population and which avoid the bias introduced by the fact that the population is not evenly distributed among all ages by repeating the calculations 10 times, once for each beginning digit, and averaging the results. The difference between the average percentage for each digit and the expected value of 10 per cent provides a measure of the preference for or avoidance of the digit over the age range considered.

Net Migration

Difference between gross immigration and gross emigration

P/F ratio Method

A consistency check for survey information on fertility. Information on recent fertility is cumulated to obtain measures that are equivalent to average parities. Lifetime fertility in the form of reported average parities by age group. P can there be compared for consistence with the parity equivalents, F by calculating the ratio P/F for successive age groups. If certain assumptions about error patterns are met, an improved estimate of

fertility can sometimes be obtained by correcting the age pattern of the current fertility to agree with the level of life time fertility reported by the younger women.

Radix

The hypothetical birth “cohort” of a “life table”. Common values are 1, 1,000 and 100,000

Sex ratio at birth

number of male births per 100 female births

Singulate mean age at marriage

A measure of a mean age at first marriage, derived from a set of proportions of people single at different ages or in different age groups, usually calculated separately for males and females

Whipple’s index

A measure of the quality of age-reporting based on the extent of preference for a particular target digit or digits. The index essentially compares the reported population at ages ending in the target digit or digits with the population expected on the assumption that population is a linear function of age. For a particular age range, often 23-62, the population with ages ending in the target digits is divided by one tenth of the total population, the result is then multiplied by 100 and divided by the number of different target digits. A value of 100 indicates positive preference for them
